Welcome to the San Ramon Valley Unified School District Board of Education meeting. Your interest in our schools is greatly appreciated.

Closed Session: Closed session meetings are not open to the public. By law, matters dealing with students and district employees are reserved for closed session to provide confidentiality. Other closed session topics can include litigation, property negotiations, and collective bargaining issues with employee associations. Members of the public are given the opportunity to speak regarding closed session items prior to the closed session.

Open Session: Meetings of the Board of Education are held for board members to conduct the district's business in public. During board meetings, board members have opportunities to recognize individuals for exemplary accomplishments, to review reports from staff, employee groups, and partnership organizations, to discuss district policies and goals, and to act on items that need formal approval. Open session is audio and video recorded.

Individuals who wish to speak before the Board of Education are asked to submit a speaker card to the Board Secretary indicating the item that you wish to address. The Board President will call you forward when the item is introduced. If you are not speaking on a particular agenda item, the Board President will recognize you under non-agenda Public Comment. All comments must be limited to three minutes. By law, board members can only discuss items that are actually on the agenda. For this reason, board members do not engage in dialogue with individuals speaking during the non-agenda public comment section of the meeting. For individuals who wish to speak with board members in depth about an issue, contacting board members on an individual basis is recommended, although individual board members have no legal authority to make decisions without consideration by the whole board.

Action items are considered and voted on individually by the board. Consent items are considered routine in nature and are approved by combining them into a single vote. A member of the Board of Education or a member of the public may request that a consent item be removed from the consent agenda and voted on separately.

Copies of board agenda backup and other informational materials provided to members of the Board of Education are available for review in the Office of the Superintendent beginning at 4:00 PM on the last working day of the week preceding each meeting of the Board of Education. For disability related modification or accommodation, please contact the Office of the Superintendent at 552-2933 during business hours.

WHEREAS, California currently has the fifth-largest economy in the world, yet 37 of 50 states, from Vermont to Alabama, spend more per student than California and our state spends nowhere near the national average on per-pupil funding; and

WHEREAS, Stanford University and Policy Analysis for California Education (PACE) published a report in 2018 that illustrated that the state would need a \$25.6 billion increase in school funding to adequately fund schools; and

WHEREAS, educating a student is significantly more expensive compared to other states due to the high cost of living; and

WHEREAS, the cost of housing is uniquely impactful for the education community in the Bay Area where costs have risen 78.4% over 15 years; and

WHEREAS, the cost to repair school facilities are higher in California than other states, as well as the cost for maintaining transportation services for students; and

WHEREAS, educating a student is uniquely challenging as California has the highest rate of poverty amongst children; and

WHEREAS, California is a beacon of opportunity for people around the world which has allowed the state to have the highest number of English Language Learners; and

WHEREAS, the United States government has not kept its promise of increased funding for the IDEA act which supports special education programs; and

WHEREAS, school districts are forced to implement unfunded mandates from the California legislature; and

WHEREAS, school districts must cope with the state-mandated rising costs of pensions with little relief from the state; and

WHEREAS, California remains at the bottom for teacher-to-student, nurse-to-student, counselor-to-student, and librarian-to-student ratios; and

WHEREAS, studies have consistently shown a positive correlation between funding levels and education outcomes;

BE IT RESOLVED, that having a week dedicated to raising awareness amongst the East Bay community and advocating our needs for increased funding is in the best interest of students; and

BE IT FURTHER RESOLVED, that the San Ramon Valley Unified School District Board of Education recognizes February 3-7, 2020 as Fund Education Now Week.



WHAT PARENTS NEED TO KNOW

Parents need to know that Jason Reynolds' Long Way Down won a 2018 Newbery Honor, Coretta Scott King Author Honor, and Michael L. Printz Honor. It's a novel in free verse that tells the story of an African American









elevator. Almost the whole novel takes place in the span of the 60-second ride from the seventh floor to the lobby, as Will's past and "The Rules" he's learned about being tough flash before him, aided by conversations very least of 44 ghosts of friends and relatives who were victims of gun violence. Multiple incidents of shootings, death, need to 44 are recalled and described. There's infrequent strong language (including one-time uses of "s--t" and "f----rs"), adult drinking, and smoking by teen and adult ghosts. In Long Way Down, Will has known about The Rules for a long time. No one he knows invented them, they've just always existed: No Crying, No Snitching, Get Revenge. When his big brother Shawn is killed, Will knows what he has to do -- he has to follow The Rules, right? The 60-second trip down the elevator from his apartment to the killer is among the longest of his life. When his past offers a different perspective on The Rules, Will has to make a tough decision: Will he go through with it?

IS IT ANY GOOD?

A stellar creepy, engaging, heartbreaking novel in verse, *Long Way Down* is another example of what author Jason Reynolds does best: Put voice to real-life issues teens face. The entire book takes place over 60 seconds of the main character's life, enough time for him to question everything he's been taught and change his life forever. Sixty seconds in this book is the difference between life and death, and readers are along for the ride from the first bing of the elevator button.

The emotions Will experiences are striking, and readers are gripped tight in the chest the entire time they're in the elevator with him. Like Will's elevator ride, the novel-in-verse's style is short and hard-hitting. Reynolds
