**TOPIC:** Reopening – Spring 2021

On Saturday, March 20, 2021, The California Department of Public Health (CDPH) updated its physical distancing guidelines for schools to align with the most recent guidelines from the Centers for Disease Control and Prevention (CDC). The new guidance allows for three feet of physical distancing in the classroom, which represents a reduction from the previous guidance of six feet. Please note, our on-going commitment to safety remains our priority.

The three feet physical distancing requirement is good news because it provides the flexibility that is needed for the SRVUSD to convert the instructional model - *for those students who selected hybrid* - from a hybrid instructional model to a full-day, in-person instructional model.

Declarations for hybrid or remote were made by families in November 2020. Families were told at the time that should physical distancing and health guidance change, the District would return *hybrid* students only to full-day, in-person instruction. Student schedules were adjusted at the beginning of the spring semester in order to facilitate a smooth transition should the opportunity arise. Declarations will not be changing. Remote learners are not impacted by the changes.

In both secondary and elementary, we are preparing to bring hybrid cohorts A and B together (Grades 1-12) for full-day instruction, four days per week, following all health and safety guidelines. Bell and student schedules will stay the same:

- TK K: Maintain current schedules in person Tuesday through Friday. Mondays would continue to be remote. This schedule may be increased through further negotiations with our labor partners.
- **Elementary Students:** Full-day, in-person Tuesday through Friday. Mondays would continue to be remote through the end of the school year, as they are now.
- Secondary Students: Full-day, in-person Tuesday through Friday. Mondays would be remote through the end of the school year, as they are now.
- Special Education Students: Maintain current schedule and services through the end of the school year.

## Mondays will remain remote for the following reasons:

#### For Elementary

• In order to meet our contractual obligations for prep time without changing any teachers in science and physical education and in some cases music.

The structure of Monday will remain the same as it is now.

## Mondays will remain remote for the following reasons:

#### For Secondary:

• Due to the following challenges: multiple passing periods, multiple contacts in one day and multiple shortened periods.

The structure of Monday will remain the same as it is now.

It is important to note the following:

- Bell Schedules remain the same
- Class Rosters remain the same
- All Hybrid students attend together Tuesday through Friday
- Mondays will stay the same
- Declarations will not change
- Our remote program will not change

The change that is being communicated through this report is bringing hybrid students back to campus for in-person instruction 4 days a week.

We are committed to supporting staff through this process, as we recognize that this has been a year filled with change. All of these changes may be very difficult for many. We believe that this change to full-day, in-person will be very good for some of our students, but we also want to be clear that we will continue to support our remote learners, as well. Each child/family/staff member will receive this change in a different way because each situation is unique. We know that and we are sensitive to emotions tied to this work. Please know that doing what is best for all students is a lofty goal and we are proud of the choice that we can offer as we strive to attain it.

RECOMMENDATION: In response to the updated guidance, the SRVUSD is recommending that we return our hybrid students to full-day, in-person instruction, four days per week, beginning on Monday, March 29, 2021\* for secondary and Tuesday, March 30, 2021\* for TK-K and elementary, following the schedules listed above.

\*For the week of March 29th *only*, because of a non-school day for students on Friday, April 2nd, schedules will be:

Elementary: Monday remote. Tuesday through Thursday full-day, in-person. Friday - no school. Secondary: Full-day, in-person block Monday through Thursday (as previously scheduled and communicated). Friday - no school.
